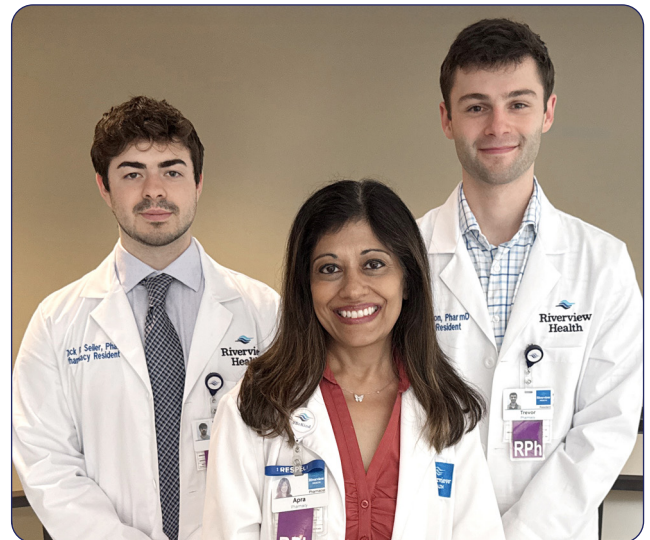

## Application Process

Applicants must apply online through ASHP's pharmacy online residency centralized application service (PhORCAS). Application requirements include:

- Curriculum vitae
- Doctor of Pharmacy degree from an accredited college of pharmacy
- Three letters of recommendation (standard PhORCAS templates)
- Copy of school of pharmacy transcripts
- Letter of intent
- Eligibility for Indiana licensure

Please note that an in-person interview will be required before being considered.
